Section VIII  SCHEDULE OF RATES  ITEM NO. 2.1	<p>With reference to the Tender No. GGPL/C&amp;P/PR 1000013/2025-26/06 dated 05.12.2025, we request clarification regarding the value to be filled in the Schedule of Rates (SOR).</p> <p>As per the SOR, the Operation and Maintenance value for the first year is required to be between 0.4% (minimum) and 1.5% (maximum) of the unit supply price.</p> <p>In this regard, kindly clarify whether the unit supply price to be considered for calculating the O&amp;M value should be inclusive of GST or exclusive of GST</p>	<p>O&amp;M value for the first year excluding GST is required to be between 0.4% (minimum) and 1.5% (maximum) of the unit supply price excluding GST i.e. Value quoted under Column no. 5 [Unit Rate (Ex works price including packing and forwarding) (including all taxes &amp; duties except GST)]</p> <p>i.e. for SOR item no. 2.1 shall be 0.4% (minimum) and 1.5% (maximum) of column no. 5 of SOR item 1.1. Similar is applicable for all other SOR items 2.2 to 2.5.</p>
